O'ahu Island Plan Beneficiary Consultation Waipahu High School Cafeteria – July 16, 2013



Dozens of Oʻahu Hawaiian homes beneficiaries helped launch the first of three Beneficiary Consultation meetings held islandwide for the Department of Hawaiian Home Lands' Oʻahu Island Plan. The Department is developing the Oʻahu Island Plan to guide management and development of trust lands on Oʻahu over the next 20 years.

Those in attendance were briefed on DHHL's current land holdings on O'ahu, as well as

beneficiary demand for homesteading on the island. Attendees discussed preliminary recommendations on land use designations and possible land acquisitions for future homestead development.

Beneficiary Consultation - Section 228 Hale Pono'i – August 21, 2013

In 2010 the State Legislature passed a law to add Section 228 to the Hawaiian Homes Commission Act (HHCA) in 2012 that would authorize DHHL to extend the term of a general lease to a maximum of 85 years for commercial/industrial or multipurpose projects.

DHHL's Land Management Division manages 1.3% of Hawaiian home lands under general leases; generating about \$10.17 million each year. Currently, the maximum term for a General Lease is 65 years. Section 228 allows for a one (1) time extension of twenty (20) years.

Before adopting and implementing (defining procedures and requirements) the law into its' Administrative Rules; DHHL must go through a lengthy process including; Beneficiary Consultation, Public Hearing, preliminary and final approval from the Hawaiian Homes Commission, the Governor, and the Attorney General.

During the month of August, DHHL conducted a series of beneficiary consultation meetings statewide on the proposed amendments to its Administrative Rules. These meetings were to inform DHHL applicants and lessees of these proposed rule changes and to receive input from beneficiaries. In addition, **beneficiaries**have until September 30, 2013 to provide further comments and feedback. The feedback to DHHL will be compiled and reported to the Hawaiian Homes Commission at a future date in preparation for the formal rulemaking process, which is expected to begin later this year. At this time, beneficiaries along with the general public will have an opportunity to comment during the upcoming public hearings.

If you were watching TV updates on "Flossie" you may have seen Bryan Miyamoto from the State Office of Civil Defense. He was a presenter at our meeting who did a very informative power point presentation along with providing several brochures, pamphlets, and books on Disaster Preparedness. What he stressed

was...Make a Plan Now:

1. Emergency Kit

Should include 7 days of food, water and medications, battery or solar powered radio, flashlight and extra batteries for both, important documents sealed in plastic bag, plastic bags and ties for waste, whistle, matches, blankets and tarps, personal hygiene items, extra cash in small bills, and a First Aid Kit.

2. Family Communication

Identify a family member that lives out-of-state that everyone can notify when they're safe.

3. Meeting Place

Choose a physical location to meet if communication between family is down.

4. Plan Escape Routes

Map out two escape routes for each room of your home and do drills with family members.

In the August and September issues of Ka Wai Ola were Public Notices to Native Hawaiians regarding the transfer of information for those who registered with OHA's Kau Inoa, Hawaiian Registry Program and Operation 'Ohana to the Native Hawaiian Roll for Kana'iolowalu. The September issue notice reads:

Native Hawaiians choosing not to be included on the Kana'ioluwalu roll will waive their right, and the right of their children and descendants, to participate in a future convention, (as described above), and as a result may also be excluded from receiving Hawaiian national rights of inclusion (citizenship), rights of participation (voting), and rights to potential benefits that may come with citizenship (e.g., land distribution, monetary payments, scholarships, etc.). Sign up now for Kana'iolowalu (www.kanaiolowalu.org or use the form on the next page) to ensure that you, your children, and your descendants are included in the process of forming a Hawaiian nation and receiving potential Hawaiian national rights.

The Legislature passed Act 77 which became effective July 1, 2013. Section 1.4 states "Nothwithstanding any other law to the contrary, including in the roll of qualified Native Hawaiians all individuals already registered with the State as verified Hawaiians or Native Hawaiians through the Office of Hawaiian Affairs as demonstrated by the production of relevant Office of Hawaiian Affairs records, and extending to those individuals all rights and recognitions conferred upon other members of the roll."

If you previously registered with one of OHA's program's and want your name transferred to the Native Hawaiian Roll for Kana'iolowalu, you don't have to do anything. Your name will be automatically transferred on September 15, 2013. If you do not want your name transferred; you must contact OHA to request that your name be left off the transfer list. You may be asked to submit your request in writing or to use their form on page 35 in their August issue.
